A regular meeting of the Knox County Board of Supervisors was held in the Boardroom at the Knox County Courthouse in Center, Nebraska on the date of August 29, 2019 at 9:30 a.m. Present were Supervisors Martin J. O'Connor District #1, Patrick J. Liska District #2, Virgil H. Miller District #3, James Sokol, Jr. District #4, Kevin D. Mackeprang District #5, Danny R. Schlote District #6 and James J. Borgmann District #7. Absent was none. Chairman Sokol, Jr. presiding.

Supr. Liska led the Board in the Pledge of Allegiance.

Chairman Sokol, Jr. announced to the public that a copy of the Public Open Meeting Act was posted in the Boardroom.

Notice of the meeting was given in advance thereof by publication in the Crofton Journal newspaper, as shown by the Affidavit of Publication attached to these minutes.

Notice of this meeting was simultaneously given to all members and a copy of their acknowledgment and receipt of notice and agenda is attached to these minutes. All proceedings hereafter shown were taken while the convened meeting was opened to the attendance of the public.

The minutes of the August 8 and August 26, 2019 meetings were read. Chairman Sokol, Jr. approved the August 8 and August 26, 2019 meetings' minutes as read.

Motion by Supr. O'Connor, seconded by Supr. Mackeprang that all claims except Claims #19080199 and #19080210, audited and approved for payment by the Claims Committee be allowed subject to delinquent personal taxes. By roll call vote. Ayes all Districts. Nays none. Motion carried.

WHEREAS, the employees of the Knox County Courthouse set up a donation box for the public to make donations to the Knox County flood relief/repair, and

WHEREAS, there was \$560 was contributed by the public, and

WHEREAS, the \$560 was submitted to the Knox County Treasurer on June 25, 2019 to be deposited into the General Fund until the Knox County Board of Supervisors could designate what the funds would be used for, and

WHEREAS, on July 25, 2019, the Knox County Board of Supervisors voted to use the donations in the amount of \$560 towards County road repair and that the Knox County Treasurer was to transfer the donations from the General Fund to the Road Fund, and

NOW, THEREFORE BE IT RESOLVED by the Knox County Board of Supervisors that the Knox County Treasurer is directed to transfer the donations of \$560 from the General Fund to the Road Fund to be used as flood damaged road repair, and

BE IT FURTHER RESOLVED, the Knox County Board of Supervisors extended their gratitude to those people who donated towards the road repair in Knox County.

Motion by Supr. Miller, seconded by Supr. Mackeprang to send a letter to all township boards informing them that complaints have been received that some Townships are not controlling noxious weeds on township road right-of ways and that according to Nebraska Revised Statute §2-956, it is the townships' responsibility to pay the costs of controlling noxious weeds in their right-of-ways. By roll call vote. Ayes all Districts. Nays none. Motion carried.

Hwy. Supt. Barta met with the Board on the following: 1. Oil crew update; 2. Bridge crew update; 3. Update on the ER, FEMA and EWP projects; 4. Engineer Jeff Wagner is having problems securing a permit from the Corps of Engineers at the Pischelville Bridge; 5. Culvert was replaced north of Center; 6. Engineer Mark Mainelli will be attending the next meeting. Discussion will be held on the Bloomfield North road project and possibly a low water crossing north of Center near Hwy. 12; 7. Update on putting in chain link fence at the Niobrara County Yard; 8. Received payment from NIRMA for replacing the windows in the Niobrara shed along with the lawn mower, chain saw, welding helmet, grinder and compressor lost during the flooding; 9. County/Township update. The permitted carry-over from 2018 needs to be spent by September 1.

The advertised bid opening for a bank stabilization project at the Pischelville Bridge was held at 10:30 a.m. The Knox County Board of Supervisors reserves the right to reject any and all bids or to waive any irregularities in bids received. Award of the contract will be in accordance with the County Purchasing Act's competitive bidding considered as set forth in Nebraska Revised Statute §23-3110. Bids were opened in the order they were received: **Flenniken Electric, Neligh NE** - \$47,538.50 (no bond included with bid); **North Construction LLC, O'Neill NE** - \$37,248.75 (bid bond included); **A & R Construction Co., Plainview NE** - \$76,893.30 (bid bond included); **Dwain Warriner Clearing &**

Grading, Creighton NE - \$67,900.25 (Certified Check for 5% of total bid included); **Rutjens Construction, Inc., Tilden NE** - \$67,786.25 (bid bond included). Chairman Sokol, Jr. closed the public hearing at 10:43 a.m. Ramsey Robertson of Mainelli Wagner & Associates and Hwy. Supt. Barta took the bids to the Highway Superintendent's Office for review.

Emergency Manager Hintz updated the Board on the following: 1. Another disaster period has been established; 2. Thirty cases of mumps have been diagnosed in several counties.

Jim and Jeannie Mackey who operate the Hideout Café in Center met with the Board to express their interest in bidding for the prisoner food contract.

County Clerk Fischer updated the Board on public transit. A survey will be conducted to see what needs Knox County residents have, if any, for additional transit services.

Chairman Sokol, Jr. opened the advertised bid opening at 11:00 a.m. for the reuse loan application of Home Town Grocery for the purchase of the People's Grocery in Crofton. Jeff Christensen with NENEDD met with the Board to discuss the application that was approved by NENEDD and recommendation to the Board to approve the application. Chairman Sokol, Jr. closed the public hearing at 11:07 a.m. Motion by Supr. O'Connor, seconded by Supr. Schlote to approve a reuse loan in the amount of \$185,000 to Home Town Grocery, Inc., to be used towards the purchase of the People's Grocery in Crofton. By roll call vote. Ayes all Districts. Nays none. Motion carried.

County Attorney Thomas met with the Board on the following: 1. Discussed hiring a part-time deputy attorney and what duties the deputy would handle including attending all Board meetings as well as Planning Commission and Board of Adjustments' meetings, filling in if medical or case load matters arose, working with all courts, conflicts of interest, future retirement of the County Attorney, and advertising for the position; 2. District Court Judge Johnson ruled on the SID#2 election case that the Plaintiffs did not demonstrate by clear and convincing evidence that Knox County Clerk's interpretation of eligible voters is in error of the changes to the election process for the Board of Trustees members of SID#2 so County Clerk Fischer is given a reasonable time to prepare the election for the SID#2 Trustees. County Attorney Thomas appeared on behalf and represented Defendant Knox County Clerk Fischer and Attorney Ryan Cwach represented the other Defendants being Coburn Construction LLC, Nest Marina LLC and Nest Yacht Club LLC.

Discussion was held on proposed updates to the Knox County Employee Handbook and the Knox County Personnel System regarding adding no-tobacco use on and in County property and equipment including use of chewing tobacco, and pre-employment contingent drug testing and random drug testing of hired employees not holding a CDL. The Handbook Committee is working on the updates and asked for the Board's opinions on the matters so they could go forward with the updates. After a straw poll, the majority of the Board was in favor of contingent pre-employment drug testing and random drug testing of those hired employees without a CDL, noting that currently those employees who do hold a CDL are already required to participate in random drug testing. As for the tobacco-free issues including use of chewing tobacco, the majority of the Board was in favor of no tobacco use including chewing tobacco in all County buildings and all County-owned vehicles and equipment but it can be used on the grounds, noting that this policy does not apply to the Knox County Jail inmates. The Handbook Committee will incorporate these results into the drafts for future review of the Board and officials.

Jerry Nipp with the Knox County Ag Society updated the Board on the recent Knox County Fair, he thanked the Board for the funds received in the past year, and that the 4-H building needs to be replaced so a request has been made to increase the levy authority given by the Board to the Ag Society by \$10,000 over last year's tax request. Discussion was held on what size of building and projected costs, and that it being in a flood plain would mean the new building would need to be raised up by 2 ½ feet. Water did get into most of the fairground buildings this year. Motion by Supr. Mackeprang, seconded by Supr. O'Connor to adopt **Resolution #2019 - 17**, as per Nebraska Revised Statute §77-3443, to allocate to the Knox County Ag Society \$90,000 for General Expenses and \$60,000 for Capitol Improvement for budget year 2019/2020. By roll call vote. Ayes Districts #1, #2, #3, #5, #6 and #7. Nays none. Abstain District #4. Motion carried.

Nays none. Motion carried. Chairman Sokol, Jr. reiterated that the executive session will be held so as to protect the reputation of an individual when discussing General Assistance Application #3-2019(2). The Board came out of executive session at 1:38 p.m.

Discussion was held on the proposed budget options of transferring \$150,000 or \$200,000 from the Inheritance Fund to the General Fund as tax relief for the proposed 2019/2020 budget. Also discussed was the creating of the position of Deputy County Attorney. Supr. O'Connor expressed for the record his dissent of the creation of the position. The position was left in the budget draft. Motion by Supr. Mackeprang, seconded by Supr. Borgmann to approve the Third Worksheet Draft of the 2019/2020 proposed Knox County Budget where \$153,000 was cut from the Road Fund Budget, \$200,000 will be transferred from the Inheritance Fund to the General Fund as tax relief, and that the proposed levy will be 0.167619 being a decrease of 0.000120 from last year noting that the 2019/2020 Budget Hearing and the Special Hearing to set the 2019 Final Tax Request will be held September 12, 2019 at 11:00 a.m. By roll call vote. Ayes all Districts. Nays none. Motion carried.
