

PROCEEDINGS OF THE KNOX COUNTY BOARD OF EQUALIZATION

A regular meeting of the Knox County Board of Equalization was held in the Boardroom at the Knox County Courthouse in Center, Nebraska on the date of December 26, 2019 at 10:04 a.m. Present were Supervisors Martin J. O'Connor District #1, Patrick J. Liska District #2, Virgil H. Miller District #3, Kevin D. Mackeprang District #5, Danny R. Schlote District #6 and James J. Borgmann District #7. Absent was James Sokol, Jr. District #4. Chairman Schlote presiding.

Chairman Schlote announced to the public that a copy of the Public Open Meeting Act was posted in the Boardroom.

Notice of the meeting was given in advance thereof by publication in the Crofton Journal newspaper, as shown by the Affidavit of Publication attached to these minutes.

Notice of this meeting was simultaneously given to all members and a copy of their acknowledgment and receipt of notice and agenda is attached to these minutes. All proceedings hereafter shown were taken while the convened meeting was opened to the attendance of the public.

Minutes of the December 10, 2019 meeting were read. Chairman Schlote approved the December 10, 2019 meeting minutes as read with the correction that the public hearing on Protests #4-2019 through #19-2019 was closed at 1:53 p.m. and action on the Protests was taken after the hearing closed.

Motion by Supr. Liska, seconded by Supr. Mackeprang to approve Tax Claim #7930 Great Plains Underground Construction, filed an adjustment on their valuation, now removing the adjusted valuation and 2019 tax dollars; #7931 Great Plains Cable LLC, filed an adjustment on their valuation, now removing the adjusted valuation and 2019 tax dollars; #7932 Netlink filed an adjustment on their valuation, now removing the adjusted valuation and 2019 tax dollars. By roll call vote. Ayes Districts #1, #2, #3, #5, #6 and #7. Nays none. Absent was District #4. Motion carried.

Co. Assessor McManigal informed the Board that the end of the year review is taking place.

There was no public comment on agenda items.

Comment on non-agenda items was given by Co. Assessor McManigal who said her office welcomes assessment questions.

Chairman Schlote adjourned the Knox County Board of Equalization at 10:23 a.m. on December 26, 2019 until 10:15 a.m. on Thursday, January 9, 2020 for a reorganizational meeting.
